LAWS (LL.M) AT THE SCHOOL OF LAW
ACADEMIC YEAR 2021-2022**

The University of Rwanda through its College of Arts and Social Sciences (CASS), School of Law is pleased to invite interested and qualified candidates for applications for the following Master programmes:

- **LL.M – Masters in Business Law**
- **LL.M – Masters in International Criminal Justice and Human Rights**

I. Entry requirements

1. **LLM- Masters in Business Law:** Bachelor's degree in Law from a recognized University, duration of the programme, 18 months.
2. **LL-M – Masters in International Criminal Justice and Human Rights:** Bachelor's degree in Law from a recognized University, duration of the programme 18 months

II. Key dates for this call

Closing of online applications: 31st August 2021

III. Required documents for application

1. A cover letter indicating the programme of study the candidate is applying for as well as his/her motivation to pursue that programme;
2. Detailed curriculum vitae (CV);
3. Notarized bachelor's degree or its equivalent issued by the Rwanda Higher Education Council (HEC) for foreigners;
4. Notarized academic transcripts;
5. Two recommendation letters from academic referees who are knowledgeable about the candidate;
6. Copy of National Identity card or Passport;
7. English proficiency certificate from a relevant body or institution for applicant(s) from countries where English is not the language of instruction in higher education

IV. Selection criteria

The selection of candidates will be based on the assessment of the documents submitted by the applicants. Only applicants who meet the entry requirement indicated above and who will have submitted all the required documents will be invited to have an interview. Candidate(s) who will have passed successfully the interview will be recommended for admission.



V. Funding

The School of Law will not give scholarships to admitted candidates. Candidates are encouraged to apply for scholarships elsewhere or can be self-sponsored.

VI. Application process

1. Go UR Website (www.ur.ac.rw)
2. Go to admission, applicant portal and click to ([New Application](#))
3. Fill in the **biographical form** and click (Save) at the end you will get “**Your Student ID Reference Number**”. *Please keep this ID Number as it will be your ID identification for all transactions at UR.*
4. Create a PIN of 5 numeric digits, do not start with a 0 (this PIN will serve as your password to access student account), leave the page and open the link below
5. Candidates are requested to submit all required documents by using the: Link pgfile.ur.ac.rw/pgfile/findme.php

- **If all required documents are not submitted, you cannot go to the next step.**
- **When your submission succeeds, a message will be sent to your e-mail box.**
